This book is primarily for a first one-semester course on CFD; in mechanical, chemical, and aeronautical engineering. Almost all the existing books on CFD assume knowledge of mathematics in general and differential calculus as well as numerical methods in particular; thus, limiting the readership mostly to the postgraduate curriculum. In this book, an attempt is made to simplify the subject even for readers who have little or no experience in CFD, and without prior knowledge of fluid-dynamics, heattransfer and numerical-methods. The major emphasis is on simplification of the mathematics involved by presenting physical-law (instead of the traditional differential equations) based algebraic-formulations, discussions, and solution-methodology. The physical law based simplified CFD approach (proposed in this book for the first time) keeps the level of mathematics to school education, and also allows the reader to intuitively get started with the computer-programming. Another distinguishing feature of the present book is to effectively link the theory with the computer-program (code). This is done with more pictorial as well as detailed explanation of the numerical methodology. Furthermore, the present book is structured for a module-by-module code-development of the two-dimensional numerical formulation; the codes are given for 2D heat conduction, advection and convection. The present subject involves learning to develop and effectively use a product - a CFD software. The details for the CFD development presented here is the main part of a CFD software. Furthermore, CFD application and analysis are presented by carefully designed example as well as exercise problems; not only limited to fluid dynamics but also includes heat transfer. To this question, put by those who advocate the complex plane, or geometry over a general field, I would reply that the real plane is an easy first step. Most of the properties are closely analogous, and the real field has the advantage of intuitive accessibility. Moreover, real geometry is exactly what is needed for the projective approach to non-Euclidean geometry. Instead of introducing the affine and Euclidean metrics as in Chapters 8 and 9, we could just as well take the locus of 'points at infinity' to be a conic, or replace the absolute involution by an absolute polarity. Teaching Mathematics in Grades 6 - 12 by Randall E. Groth explores how research in mathematics education can inform teaching practice in grades 6-12. The author shows preservice mathematics teachers the value of being a "researcher—constantly experimenting with methods for developing students' mathematical thinking—and connecting this research to practices that enhance students' understanding of the material. Also introduced are the language of topology and fundamental concepts of calculus: the limit, the differential, and the integral. A special section is devoted to analysis on manifolds. The second part "Operators" describes the most important function spaces and operator classes for both linear and nonlinear operators. Different kinds of generalized functions and their transformations are considered. Elements of the theory of linear operators are presented. Spectral theory is given a special focus. The third part "Ill-Posed Problems" is devoted to problems of mathematical physics, integral and operator equations, evolution equations and problems of integral geometry. It also deals with problems of analytic continuation. Detailed coverage of the subjects and numerous examples and exercises make it possible to use the book as a textbook on some areas of calculus and functional analysis. It can also be used as a reference textbook because of the extensive scope and detailed references with comments. Manifolds, Groups, Bundles, and Spacetime was written for those who are interested in modern differential geometry and its applications in physics. The primary material is suitable for a graduate level course in the theory of differentiable manifolds, Lie groups, and fiber bundles. The first two chapters are an introduction to concepts from linear algebra and tensors and can be read to establish familiarity with the notation and conventions of the text by those who are already familiar with these topics. The third and fourth chapters are a review of topics from advanced calculus and topology and are included primarily as a convenient reference. Geometry with Trigonometry Second Edition is a second course in plane Euclidean geometry, second in the sense that many of its basic concepts will have been dealt with at school, less precisely. It gets underway with a large section of pure geometry in Chapters 2 to 5 inclusive, in which many familiar results are efficiently proved, although the logical frame work is not traditional. In Chapter 6 there is a convenient introduction of coordinate geometry in which the only use of angles is to handle the perpendicularity or parallelism of lines. Cartesian equations and parametric equations of a line are developed and there are several applications. In Chapter 7 basic properties of circles are developed, the mid-line of an angle-support, and sensed distances. In the short Chapter 8 there is a treatment of translations, axial symmetries and more generally isometries. In Chapter 9 trigonometry is dealt with in an original way which e.g. allows concepts such as clockwise and anticlockwise to be handled in a way which is not purely visual. By the stage of Chapter 9 we have a context in which calculus can be developed. In Chapter 10 the use of complex numbers as coordinates is introduced and the great conveniences this notation allows are systematically

exploited. Many and varied topics are dealt with, including sensed angles, sensed area of a triangle, angles between lines as opposed to angles between co-initial half-lines (duo-angles). In Chapter 11 various convenient methods of proving geometrical results are established, position vectors, areal coordinates, an original concept mobile coordinates. In Chapter 12 trigonometric functions in the context of calculus are treated. New to this edition: The second edition has been comprehensively revised over three years Errors have been corrected and some proofs marginally improved The substantial difference is that Chapter 11 has been significantly extended, particularly the role of mobile coordinates, and a more thorough account of the material is given Provides a modern and coherent exposition of geometry with trigonometry for many audiences across mathematics Provides many geometric diagrams for a clear understanding of the text and includes problem exercises for many chapters Generalizations of this material, such as to solid euclidean geometry and conic sections, when combined with calculus, would lead to applications in science, engineering, and elsewhere
